OUR AIM IS:-

- To enhance the development and education of children under statutory school age in a parent-involving community based group.
- To provide a safe, secure and stimulating environment.

We also offer a lunch club on Monday, Thursday and Friday from 12.00pm - 1.00pm for a small fee.

Pre-School offers education and care for children below school age and over the age of 2.

We aim to provide the children with opportunities to form friendships with those children that they will start school with, helping them to gain independence and provide them with the skills which will make the transition into school easier.

We are OFSTED inspected and can provide free sessions for all 3 and 4 year olds and some 2 year olds under the Government Nursery Education Scheme.

The Pre-School operates a No Smoking Policy.

CURRICULUM

Within the group, all children are supported in developing their potential at their own pace. We provide a planned curriculum tailored to the needs of each individual child. By means of developmentally appropriate play activities and a high level of individual adult input, we can offer a curriculum which leads to approved early learning goals in the Early Years Foundation Stage.

Prime areas are fundamental throughout the Early Years Foundation Stage. They are:

Personal, Social and Emotional Development

Communication and language

Physical Development

Specific areas include essential skills and knowledge for children to participate successfully in society. They are:

Literacy

Mathematics

Understanding the World

Expressive Arts and Design

SNACK TIME

During each session a healthy snack will be offered to each child. The children are offered either water or milk to drink and something to eat. They are also offered a fruit or vegetable option. We offer a wide range of food often in line with the themed activity to encourage the children to try a new and varied range of foods. Drinking water is available to the children throughout the session.

ASSESSMENTS

We keep development files for each child. Monitoring progress enables us to provide for each child's individual needs, as they develop at their own rate. The files help us to provide information to parents, which are always readily available, and can be passed on to school if required. We give parents the opportunity to contribute to their children's records.

TRAINING

Our staff are well qualified and regularly attend on-going training through the Early Years Partnership with Derbyshire County Council. Staff regularly update their training files after attending a course and their training needs are discussed at their annual appraisal.

THE ROLE OF PARENTS

The Pre-School recognises parents as the first and most important educators of their young children. Parents are welcome:

- to work in the group with the children, should they wish to volunteer.
- to assist with fund-raising.
- to offer their thoughts and views on ways that we can improve our setting for the children.

POLICIES

A copy of our policy statements are available at any time, and can be found on the notice board as you enter Pre-School. All our policies are designed to offer the best possible experience for

the children and families in the group. Our policies are reviewed on a regular basis and comments and suggestions from parents are always welcome.

ADDITIONAL NEEDS

The number of adults present in the Pre-School enables us to provide individual attention for each child. Each child is able to progress at their own rate in all areas of development, and this is true for children with and without disabilities or learning difficulties. We are experienced in working in close liaison with professionals across a range of additional needs. If you would like to discuss your own child's additional needs, please talk to the Pre-School Supervisor. We have an appointed co-ordinator, Sam Brooks, who keeps up to date on this subject and cascades this information onto others. Our full additional needs policy is available from any member of staff.

MANAGEMENT AND ADMINISTRATION DECISION MAKING

Etwell Pre-School is a Community Interest Company (CIC) which is a limited company, registered with Companies House. However, the company is run for the benefit of the community rather than an individual(s). The assets and any profit made have to be retained within the company and so benefit the community we serve. The directors of the company are responsible for reviewing both policy and practice, and the employment of members of staff.

FEES

Fees are **£16.50** per session for 3-year-olds and **£18.00** per session for 2-year-olds, payable half-termly in advance. The lunchtime sessions cost **£6.00** per session. Fees continue to be payable if a child is absent without notice or for a short time. We also charge **£1/child/morning session for snack and equipment**. In cases of prolonged absence, parents should consult the Pre-School supervisor. Each child's attendance at the group is conditional upon the continued payment of any necessary fees. The Payment Policy is available for parents to view at any time, this also gives information about Government funded places. **Please note that your child must attend for a minimum of 2 sessions per week.**

We are registered to accept payments through Tax Free Childcare.

SNOW CLOSURE

In the case of Etwell Pre-School being closed due to bad weather we will post an announcement on the Pre-School website at 8.30am on the day. STARTING PRE-SCHOOL - THE FIRST DAYS

A child who is tense or unhappy will not be able to play properly, so it is important for parents and Pre-School staff to work together to help the child feel confident and secure in the group, this takes longer for some children than others and parents should not feel worried if their child takes a while to settle. The Pre-School policy on settling is available for you to read at any time.

WHAT TO WEAR

In order to feel free to explore and experiment with all kinds of materials, including messy ones, it is best to send children dressed in clothes which are easily washable or are not new. It is good for children to practice the skills which will make them independent. Simple clothing that they can handle themselves will enable them to go to the toilet when they want to and to put on and take off their outdoor clothes without being too dependent on other peoples help.

Please send your child with outdoor clothing appropriate to the weather conditions. We would ask that outdoor clothes be named.

We hope that your child's time in Pre-School will be a very happy and productive one. If you have any queries or if we can be of any help, please speak to a member of staff or the directors at any time.
